

WELCOME TO EINDHOVEN AIRPORT

To ensure that everyone's time at Eindhoven Airport is as pleasant as possible, the following house rules apply as part of the Airport Regulations of Eindhoven Airport:

- When at the airport, it is forbidden for anyone to act in a manner that is upsetting to users of the airport. Misbehaviour includes harassing individuals, fighting, participating in unlawful assemblies, unnecessarily pushing forward, retrieving items (e.g. plastic bottles) from a waste bin, and giving rise to disorderliness through challenging behavior. In case Eindhoven Airport N.V. thinks that aggressive and threatening behavior or any other form of behavior that causes a nuisance is the case, the behavior in question will be reported to the Royal Netherlands Military Constabulary (*Koninklijke Marechaussee*).
- All individuals are required to act according to the content of communications (boards, flyers, displays, etc.) issued by Eindhoven Airport N.V.
- All instructions issued by or on behalf of Eindhoven Airport N.V. must be followed.
- It is forbidden to drink alcohol outside the catering areas indicated for this purpose. It is also forbidden to use drugs.
- It is forbidden to be under the influence of drinks or drugs at the airport; this includes the catering areas.
- Smoking or the use of alternative smoking materials, including the use of electronic cigarettes, is prohibited in the terminal, the marked area in front of the entrance of the terminal, on the terraces, on the apron, and in the parking garages. Smoking is only permitted in the designated areas on the forecourt of the terminal.
- It is forbidden to be on the airport site, or a part of the airport site, at a time when it is closed or not accessible.
- It is forbidden to leave luggage unattended.
- It is forbidden to cause nuisance, danger, contamination, or damage in any manner whatsoever.
- It is forbidden to lie or sleep in the public part of the airport.
- It is forbidden to misuse facilities at a time when they are not available for use or in a manner other than that for which they are intended.
- It is forbidden to misuse emergency exits or to block doors, hallways, traffic lanes, or fire-fighting equipment.
- When at the airport, it is forbidden for anyone to have animals, substances, and/or objects that cause, or could cause, a nuisance, danger, contamination, a disturbance of the peace, or damage.

- It is forbidden to roller skate, skate, skateboard, and/or ride a scooter, moped, or bicycle.
- It is prohibited to take photos, videos, and/or film recordings other than for private use, unless this is also expressly prohibited at specific locations as indicated, and/or written permission has been obtained granted by Eindhoven Airport N.V.
- It is forbidden to beg on the airport site. It is also prohibited to take collections without the written permission of Eindhoven Airport N.V.
- We monitor security for your safety and our own. This includes the use of cameras.
- Each individual is required to be in a position to prove his/her identity by producing legally valid proof of identity.
- Eindhoven Airport N.V. will not, in any way whatsoever, assume liability for theft, loss, destruction, or damage of any nature at all, except where serious shortcomings on its part are found to be the case.
- Lost-and-found items will be stored at the information desk in the Terminal for one month. After 1 Month items will be handed over to the city council of Eindhoven.
