- Pharmaceutical market: Drug expenditure in USDbn and in local currency terms, % of GDP and per capita (USD).
- Patented drug market: Prescription drug sales in USDbn and in local currency terms, (% of total sales).
- **Generic drug market:** Generic product sales in USDbn and in local currency terms, generic sales (% of total sales).
- OTC drug market: OTC sales in USDbn and in local currency terms, (% of total sales).

BMI's Pharmaceuticals Risk/Reward Index

BMI's Risk/Reward Index provides investors (both national and multinational) looking for opportunities in the region with a clear country-comparative assessment of the market's risks and potential rewards. Each of the 110 country markets are scored using a sophisticated model that includes more than 40 industry, economic and demographic data points to provide indices of highest to lowest appeal to investors, with each position explained.

Regulatory Review

The competitive landscape section provides comparative analysis of the major pharmaceutical companies operating in each market.

Detailed Company Profiles*

Examines the competitive positioning and short- to medium term business strategies of key industry players. Innovative Pharmaceuticals Risk/Reward Index

Our Innovative Pharmaceuticals Risk/Reward Index (RRI) quantifies and ranks a market's attractiveness in terms of its pharmaceuticals market; it balances the **Risks** and **Rewards** of launching innovative medicines in different countries.

To form a country's RRI score, we combine industry-specific characteristics with broader economic, political and operational market characteristics. We weigh these inputs in terms of their importance to investor decision making in the pharmaceutical industry. The result is a nuanced and accurate reflection of the realities facing investors in terms of the balance between:

1) opportunities and risk; and 2) sectorspecific and broader market traits. This enables users of our RRI to assess a market's attractiveness in both a regional and global context.

The RRI also encompasses a combination of our proprietary forecasts and analyst assessment of the regulatory climate, as well as globally acceptable benchmark indicators (eg, Transparency International's Corruption Perceptions Index). As regulations evolve and forecasts change, so does the RRI score, providing a highly dynamic and forward-looking result.

The Innovative Pharmaceuticals Risk/Reward Index universe comprises 110 countries.


