

Electronic Delivery Consent

This consent to the electronic delivery of documents and communications (this “Consent”) applies to your use of Coinbase’s website, including any subdomain thereof (the "Website"), the mobile application (the "App"), and/or products and services offered, operated or made available by us via the Website or the App (the “Services”). If you provide this Consent, it applies even if you do not obtain (or are not offered) the Services. In this Consent, "us," "we," or "our" refer to Coinbase Capital Markets Corporation, its affiliates (collectively “Coinbase”) , and our service providers.

By agreeing to this Consent:

- You consent to receive Account Documents and all other forms of communication (collectively, “Communications”) electronically as described herein;
- You acknowledge that you can access and read information we post on our App or Website;
- You agree to provide a current email address at which we may send electronic Communications to you.

This Consent will remain effective until: (1) you or we have closed all Accounts you have with us; or (2) you withdraw your consent to receive electronic Communications. If you withdraw your consent following the approval of your application, Coinbase has the right to restrict and/or immediately close your Account, require you to transfer your assets, and terminate your access to our services. If your Account(s) are closed, your Consent will still continue with respect to our pre-termination rights (including rights created by this Consent).

Electronic Records and Signatures

As part of your use of our Services, you are entitled by law to receive certain information in writing. You acknowledge and agree that your consent to electronic Communications is being provided in connection with a transaction affecting interstate commerce that is subject to federal Electronic Signatures in Global and National Commerce Act (the “E-Sign Act”), and that you and we both intend that the E-Sign Act apply to the fullest extent possible to validate our ability to conduct business with you by electronic means. Please read this Consent carefully and keep a copy for your records.

Your consent is voluntary, but we cannot process your application or provide our products and services to you if you do not consent. The decision to do business with us electronically is yours. If you are unwilling to receive these disclosures and notices electronically, you may cancel this transaction at no cost by closing your mobile app or browser before accepting and proceeding past this Consent.

Scope of Communications to Be Provided in Electronic Form

By agreeing to this Consent, you agree to receive electronically all forms of communications and Account Documents, which include notices, contracts, disclosures, current and future account statements, trade confirmations, prospectuses, offering circulars, and supplements for securities you purchase, proxy materials and all other forms of shareholder communications, tax-related documents, and any other information, documents, data, and records regarding your

Account, this Consent, and the agreements and disclosures governing the services delivered or provided to you by Coinbase or any other parties arising from or relating to your use of the Website, the App, or any product or service we offer, including but not limited to applications for financial products, any financial products you may request or receive, or your creation of an account with us (each, a "Communication").

Method of Providing Communications to You in Electronic Form

All Communications that we provide to you in electronic form will be provided either (1) via email, (2) through our App, and/or (3) via the Website.

Request for Paper Copies

Upon your request, you may obtain electronic copies of your Account statements and trade confirmations, subject to availability.

Withdrawing Consent

Consent to electronic delivery of Communications is required to establish and maintain an Account with

CCM. If you wish to withdraw your consent to receive Communications electronically, you may do so by reaching out to us at help.coinbase.com. Select a category under Get support with your issue. Choose the option that best describes your problem for specific information. Under Contact us, feel free to select Live chat or Request a call for further assistance. You can also call us at +1 888-908-7930.

You may withdraw your consent at any time. If you do withdraw your consent prior to the approval of your application, this will prevent you from receiving products and services from us over the Internet. If you withdraw your consent following the approval of your application, Coinbase has the right to restrict and/or immediately close your Account and terminate your access to our services. If you decide to withdraw your consent, the legal effectiveness, validity and/or enforceability of any prior electronic Communications will not be affected.

How to Update Your Records

It is your responsibility to provide us with a valid phone number, mailing address, email, and other information related to your account, and to keep such information up to date and update promptly any changes in this information. You understand and agree that if we send you an electronic Communication but you do not receive it because your valid phone number or email address in your account is incorrect, out of date, blocked by your service provider, or you are otherwise unable to receive electronic Communications, we will be deemed to have provided the Communication to you.

Your use of a spam filter that blocks or re-routes emails from senders not listed in your email address book may impact your ability to receive our Communications. Therefore, you must add Coinbase to your email address book so that you will be able to receive the Communications we send to you.

You can update your phone number or email address information through your dashboard by logging on to the App.

Potential Costs Associated with Electronic Delivery

Potential costs associated with electronic delivery may include charges from Internet access providers and telephone companies, costs to download, print and store delivered documents, and you agree to bear these costs. Coinbase will not charge you additional online access fees for receiving electronic delivery of trade confirmations, account statements, agreements, tax forms, prospectuses, offering circulars, and supplements for securities you purchase, proxy materials and all other forms of communication. If you fail to maintain a valid and/or deliverable email address of record on your Account, Coinbase reserves the right to charge you a fee for certain documents that must be re-delivered via mail. You may incur such fee for each instance of postal mail delivery until such time as you update your email address.

Hardware and Software Requirements

To access, view, and retain electronic Communications that we make available to you, you must have:

- An iOS or android mobile device which is capable of accessing the internet. Your access to this page verifies that your system/device meets these requirements;
- An internet web browser which is capable of supporting 128-bit SSL encrypted communications to ensure the information sent between us and you is transmitted and stored safely;
- Sufficient electronic storage capacity or other data storage unit, and the ability to view files; and
- Connection to the internet capable of receiving, accessing, displaying, and either printing or storing Communications received from us in electronic form via text or email or by access to our website using a browser.

By giving your consent, you are confirming that you have access to the necessary equipment and are able to receive, open, and print or download a copy of any electronic Communications for your records.

Retaining Copies of the Communications

You may make copies of the electronic Communications we send by using the “print” or “save” functionality of the application in which you are viewing them (e.g., Web browser, Adobe® Reader® software). We may not retain copies of Communications for any period of time longer than what is required of us by law. Save or print copies of the Communications to ensure you have them when needed.

Communications in Writing

All Communications in electronic format from us to you will be considered “in writing”. You should print or download for your records a copy of this Consent and any other Communication that is important to you.

Termination or Changes

We reserve the right, at our sole discretion, to discontinue the provision of your electronic Communications, or to terminate or change the terms and conditions on which we provide

electronic Communications. We will provide you with notice of any such termination or change as required by law.
