Explanations

- 1 Additional charges to service fees.
- 2 Transaction must be sent to Nets no later than three days from the purchase date.
- 3 Fee for conversion between two currencies that is charged in a foreign currency. Nets can receive multicurrency transactions in all foreign currencies. Settlement can be made in the currencies: DKK, EUR, GBP, SEK, NOK, ISK, CHF, LTL, LVL, PLN, CZK, HUF, TRY, USD, CAD, JPY, AUD, NZD, HKD, HRK, SGD, ZAR and MXN. Register an account for each currency. If transactions in foreign currency are not converted to local currency the fee for multicurrency will not be charged.
- 4 Fee for all cross-border volume in a different currency than merchant country currency.
- 5 Pre-auth. is a temporary hold of an amount on the cardholder's card which is typically released after a few days or until post-authorization. Fee of the pre-authorized amount.
- 6 Tokenization turns the 16-digit card number into a different number stored on the card holder's device so, the actual card details are never shared and therefore makes it a more secure transaction.
- 7 The Alipay start-up fee is shown without VAT but will be taxed.
- 8 The fee covers Nets costs to the card companies for a special registration fee and quarterly reporting on products and services categorised as high risk. If your products/ services are high risk category, we will let you know before formation of a contract.
- 9 Through MyNets Portal statements are free of charge.
- 10 Per legitimate cardholder dispute.
- 11 Statistical material, call centre services, data extracts and data analysis
- 12 DCC is a service for currency conversion at the time of the transaction. The cardholder will be presented with the option of paying in her/his own currency or the local currency when paying. The exchange fee is 4.75% where Merchant keeps 1% of the transaction amount and Nets keeps 3.75% of the transaction amount.
- 13 Non-compliance prices appear in USD and EUR on the prices list, as these are directly charged to Nets in these currencies by Visa and Mastercard. The prices will be converted to your billing currency with mark-up pursuant to the daily conversion rate of Danske Bank.
- 14 Both percentage and per transaction price applies.
