#### 11. General conditions:

All IMO labels shall be removed by the truck driver prior to entry. Should this requirement not be fulfilled, NST will arrange for removal at an additional cost.

Units between 20' to 40' are calculated as 2 TEU (includes 22', 23', 26', 30', 40' units). 45' containers are calculated as 3 TEU.

Northsea Terminal reserve the right to make changes to the Tariff with 30 days of notice.

Any claim shall be limited to SDR 10 000 (in accordance with NSAB 2000. All cargo stored at NorthSea Terminal at the owner's cost and risk (uninsured).

Units not booked on EDI, which will demand NorthSea Terminal to create a manual booking in the system, will be charged Manual Gate fee per unit.

Creation of a booking will result in the application of a Manual Booking Fee for each unit processed manually.

Manual gate assistance provided to drivers during check-in shall incur a Manual Gate Fee for each unit processed.

All empty containers arriving by truck will be transferred to the MNR area for inspection, additional cost for lift and inspection

Containers transferred from one owner to another in the Terminal system will be charged Line Transfer Fee.

All Terminal services to be charged biweekly.

Overdue amounts shall be subject to late payment interest at a rate of 2% per month. Furthermore, DFDS shall be entitled to full compensation for all costs and damages incurred as a consequence of non-payment or late payment for the services rendered.

NorthSea Terminal will not accept any claims or remarks regarding cars, caravans, machinery, trailers, or similar units that have been moved prior to notifying terminal staff.

Furthermore, NorthSea Terminal reserves the right to classify prices for any unclassified units.
