* Commodity Rate : To be applied to Bricks/blocks/slates/roof tiles/cobbles/pavers, timber (sawn/chipboard/MDF, not joinery or window frames/trusses etc.), steel, straw, animal feed, export recyclables, cement, insulation, gypsum, peat, fertilizer, fuel, gas (LPG) tankers & agricultural exports from Jersey. Empty trailer returns of previously laden 'commodity' trailers will also attract the commodity rate.
